May 2024

U.S. existing-home sales fell for the second month in a row, sliding 1.9% month-over-month and 1.9% year-over-year, according to the National Association of REALTORS® (NAR), with sales down in all four regions of the country. Higher borrowing costs and accelerating home prices continue to weigh on demand, pushing some prospective buyers to the sidelines and causing market activity to slump ahead of summer.

New Listings were up 17.5 percent for single-family homes and 5.8 percent for condominium properties. Closed Sales increased 6.9 percent for single-family homes but decreased 0.5 percent for condominium properties.

The Median Sales Price was up 7.3 percent to \$660,000 for single-family homes and 4.4 percent to \$569,000 for condominium properties. Months Supply of Inventory increased 12.5 percent for single-family units but decreased 4.5 percent for condominium units.

Home prices have continued to climb nationwide, despite an uptick in inventory this year. Nationally, the median existing-home price reached \$407,600 as of last measure, a 5.7% increase from the same period last year and a record high for the month, according to NAR. Meanwhile, total inventory heading into May stood at 1.21 million units, a 9% increase month-over-month and a 16.3% increase year-over-year, for a 3.5 month's supply at the current sales pace.






Historical Closed Sales by Month




Historical Median Sales Price by Month



Housing Affordability Index



This index measures housing affordability for the region. For example, an index of 120 means the median household income is 120% of what is necessary to qualify for the median-priced home under prevailing interest rates. A higher number means greater affordability.


Historical Housing Affordability Index by Month






Historical Months Supply of Inventory by Month




Historical Final Days on Market by Month




Historical Cumulative Days on Market by Month



Percent of Original List Price Received




Historical Percent of Original List Price Received by Month


